Services: Outpatient substance abuse treatment for adult men and women ages 18 and older. 18 year olds may be referred to an adolescent program if it is felt that would be a more appropriate treatment option. Program is abstinence based. Treatment is individualized based on the needs of the client. Treatment consists of group therapy, individual counseling, and educational sessions. Day and evening hours are available.

The program meets Monday, Tuesday, and Thursday. The hours are from 1-3 p.m. in the day program and 6:30-8:30 p.m. in the evening program. The primary program, Phase I, is generally 20 sessions followed by 12 Phase II sessions once a week. Family involvement is offered. All counselors are licensed as alcohol and drug counselors by the State of Minnesota.
